Opportunities identified by Senior Advisory Board

1. Expand services at the center

- 1. Local authors and poetry nights
- 2. Musical night: ie. Singing, instrumental
- 3. Cooking demonstrations where the food is demonstrated and people leave with a recipe and ingredients.
- 4. Open center to community groups to meet and make presentations
- 5. Survivor meetings: cancer, grief,
- 6. Evening classes: weight loss; walking; book; gardening; needle/craft
- 7. Animal therapy: bunny, dog, llama
- 8. Senior/child based activities: kids teaching adults and adults teaching kids; share a movie and popcorn with someone
- 9. Outreach within community to advertise what services are at the center
- 10. Health options: hearing van, blood bank, adaptive devices for your house as you age (lamp adaptors, door bells and lights to attract attention, hand rails, hand holds in the bathroom, numbers on your house). Fall prevention and what to do if you do fall!

2. Building/ Appearance/Appeal/Capacity:

- 1. improve visual aspect of the outside of the center through more consistent maintenance and plants to enhance the appeal
- 2. outdoor table for "coffee and chatter" Canopy for sunny days
- 3. painted mural on outside
- 4. signage to advertise what is happening: i.e. "what's up at the center" (Sandwich board)
- 5. continue partnership with the Sr. Center Foundation for targeted improvement

3. Increase community awareness and involvement with the Senior Center

- 1. weekly or monthly community nights: i.e. movie, trivia, cookie exchange, theme nights
- 2. community residents sharing their vocations/hobbies
- 3. community presentations on topics of interests: **example**: the holocaust presentation; gardening; adapting your yards to eco-friendlier practices
- 4. align the activities at the center with the city web site calendar
- 5. wine and cheese nights/ paint and wine nights
- 6. increase social media and awareness of center activities
- 7. master gardener/master recycler classes
- 8. explore the topic and impact of a name change for the center.

Traffic Safety Advisory Board Work Plan 2022

GOALS FOR 2022:

- 1. Create an inbox for ideas from the community that is linked to the website (In process)
- 2. Messaging Traffic Safety information in the Newsletter, Twitter, Facebook, etc. (continue through 2022)
- 3. Develop a strategy to increase participation in meetings (In process, Andrew and Yvonne)
- 4. Awareness presentations for the community (Community Events, (example, bike Rodeo, Festival, Social Media)
- 5. Help identify police missions involving traffic safety, Pedestrian safety, etc. (on going)
- 6. Attend other city/county traffic safety meetings for ideas (Starting 2022)
- 7. Address traffic issues throughout the city. (Utilize grant funding for speed and pedestrian enforcement, etc.)
- 8. Board members work with other city board members to understand where future projects can be worked on jointly or combined. (on going)

The Traffic Safety Advisory Board has reviewed the 2021 goals and revised its goals for 2022. The top priorities have been taken from the 2017 City of Gladstone Transportation System Plan and we are providing them as recommendations for council consideration. These recommendations are pedestrian safety based and at least one is linked to a goal of the parks commission.

- 1. P40 Webster Rd / Cason Rd. Enhanced Crossing. "Install an enhanced pedestrian crossing with raised median islands, high visibility pavement markings and signs, and RRFBs. Also, reduce curb radii in the northeast corner of the intersection. "H" \$85,000 Target date for completion 2022. The crossings will have flashing beacons and possibly a middle island. There are some engineering hiccups right now which could push the project completion out a bit but hoping the project meets the anticipated date.
- 2. Reduce Oatfield Rd speed from 35-30 MPH from 82nd north to city limits / Reduce Webster Speed from 35 to 30 MPH. Currently working with public works to evaluate speed reduction on Webster Rd from 35 to 30 MPH.

Items the board will research moving forward:

- Crosswalks to change from unmarked to marked Identifying appropriate intersections and update current marked crosswalks.
- P32 Jennings / Valley View Rd. "Enhanced Crossing" Install an enhanced Pedestrian crossing "H" \$25,000. This crossing is confirmed City of Gladstone roadway on Jennings.
