## Management of Gladstone's Most Valuable Asset

Your Gladstone Rights-of-Way: The City's Most Valuable Asset!

#### **About Rights-of-Way**

Gladstone's "rights-of-way" are sections of land set aside for public benefit. These sections include streets and sidewalks as well as land set aside for water pipes, electricity lines and other utility infrastructure.

Our City's rights-of-way are our most valuable asset and include all the property and improvements on all of Gladstone's streets. Gladstone coordinates right-of-way use among public and private users so that we can efficiently manage this large and complex resource.

#### **New Ordinance**

On May 31, 2016, The Gladstone City Council adopted Ordinance #1465 requiring all utilities to have a contractual agreement or a license to use the City's rights-of-way.

The goal is to accurately identify all right-of-way users and ensure fair, market rate compensation for the use of our most valuable asset.

Prior to the ordinance, four utility companies had obtained a license to operate within the City's right of way. Through these efforts, seven additional utility companies were identified and are in process of obtaining a license.

The Public Works Department manages the new Ordinance through a short term contract with Oregon City's Right-of-Way Program Manager, Lance Powlison.

### Right-of-Way FAQ

#### Right-of-Way Frequently Asked Questions

Q: Why does the City charge utilities for using rights-of-way?

A: The rights-of-way are owned by the City. The responsibility to fund improvements and service for our rights-of-way ultimately rests with the taxpayers. In order to ensure a fair distribution of these costs, the City charges utility customers and others that use the right-of-way rather than passing the costs directly to only property taxpayers.

Q: How much does the City charge for using rights-of-way?

A: The amount varies based on the kind of utility and how much facilities they use in the right-of-way.

Q: Does the City charge only private utilities or are publicly-owned utilities charged as well?

A: The City charges any user whether they are private (such as Portland General Electric) or public (such as the Tri-City Wastewater Treatment Plant and even the City's own utilities).

Q: Is it common for cities to charge these fees?

A: Yes. Most cities in Oregon have some kind of right-of-way management policy and charge fees for its use. The League of Oregon Cities has provided model right-of-way ordinances for cities to use and the Gladstone Ordinance is based on that model. Many other local governments in the area, such as West Linn, Oregon City and Clackamas County, charge right-of-way fees to users.

Q: How does this affect me?

A: Before the new ordinance, each utility company had individually negotiated contracts. Now the requirements and fees are fixed, which eliminates City staff and legal time, thus increasing efficiency. The Ordinance also helps the City coordinate right-of-way use so that improvements and construction happens more efficiently.

Q: Why a new policy?

A: Gladstone has aging infrastructure and is aware that careful coordination of its rights-of-way policy has become a necessary part of responsible management.

Q: Can these fees be negotiated?

A: Generally no. The fees are set by a resolution of the City Council. However, Gladstone staff has been in touch with cable utility users to negotiate their fees as required by federal law.

# Maintenance and Improvements in Rights-of-Way

The City of Gladstone is excited to let you know that we'll be doing some maintenance and improvements in your rights-of-way, parks, and other public property throughout Gladstone.

#### **UPCOMING MAINTENANCE AND IMPROVEMENTS**

For decades Gladstone has charged franchise fees to utilities for use of the public rights-of-way. A few months ago the franchise fee was put into the Code for increased efficiency, transparency, and equality between users.

The franchise fee, now called the Right-of-Way usage fee, helps cover the costs of maintenance, improvements, and management of your public facilities. This fee fairly distributes the costs among utilities that use the rights-of-way, so that Gladstone residents don't have to shoulder the entire burden.

The recently changed PGE and NW Natural Right-of-Way usage fee now brings these utilities in line with other cities in Clackamas County, as well as the fees other utilities pay in Gladstone.

To learn more, here are some FAQ's.

#### FAQs:

Q: What's going to be different?

A: Utilities will be charged a user fee (like a rent) when they use City-owned lands in Gladstone. These fees help the City repair and maintain your public rights-of-way and other spaces. Utilities can pass these costs along to ratepayers. Under the new policy, the fee is collected from all users of the rights-of-way, including service districts and utilities. This means that the burden is shared by all users, and not just Gladstone taxpayers.

Q: How will my bill be affected?

A: The new policy spreads costs to utility companies who use the public rightsof-way rather than just all taxpayers. Changes to your bill will be affected by your utility use. Generally, any increases should be about the cost of a cup of coffee each month. Check your own utility bills for exact amounts.

Q: This is labeled a "Privilege Tax" on my customer notice. But Gladstone is calling it a "fee". So which is it?

A: The Oregon Supreme Court has recognized that a "Privilege Tax" is not necessarily "tax" as opposed to a fee. PGE and NW Natural are choosing to label it a "privilege tax" for their purposes. Contact PGE and NW Natural to learn more about their billing language.

Q: How will the City spend the money collected from these fees?

A: The right-of-way user fees will go through the City's general fund. The Gladstone Council will ultimately decide how and where the money is spent.

Q: Why is the City doing this now?

A: Several larger cities in Oregon already have this kind of policy in place. Recently, Gladstone has determined that careful coordination of our rights-of-way have become a necessary part of responsible management.

Q: How is this fairer to ratepayers?

A: Even without this fee structure in place, Gladstone pays for costs associated with the management, upkeep, and repair of our rights-of-way and public lands. Without a policy to regulate rights-of-way users, utility companies were using the ROW for free, forcing the City to choose between forgoing certain maintenance or pass the costs along to all taxpayers.



#### Leaf Pick Up

Our beautiful autumn leaves will soon be falling, which means leaf pick up season is coming! In an effort to best utilize public funds, the Public Works Dept. has slightly changed the leaf pick up schedule this year. It is our hope this new scheduling method will allow us to cover our leaf pick up areas in the most cost effective manner, saving your dollars in both manpower and equipment hour costs. We will be picking up leaves with in the date ranges above. Please identify your neighborhood area on the map above. Please have your leaves placed in one large pile in the street, at least one foot from the curb. This extra space between the curb and leaf pile allows water to drain into the city's catch basins. Please have your leaf pile ready for pick up on the first day of your area's designated pickup date. Leaves placed in the street too far in advise will cause leaves to wash into storm drains, increasing the risk of flooding. Put leaves out the day before your area's first scheduled day. The City does not have a chipper or a way to dispose of tree limbs or twigs, so please do not mix anything in with your leaves. Public Works always appreciates our residents cooperation in assisting to keep our city streets clean and our catch basins clear of leaves, allowing water to drain way from homes & businesses. Once our crews have visited your area, they will not return until the next scheduled pick up date for your area. The year's pick up schedule ends December 16th. December 19th—January 13th, the public works crew will do large pile pick up. This post-season pick up will be by request only for citizens with hardships that prevented previous pick up. Large leaf piles must be at least two heaping wheel barrow loads. Smaller amounts may be placed in your yard debris cans. - \*must pass the entrance physical ability test, written exam (70% or better) and interview to be accepted for the department fire academy;
- \*must obtain State of Oregon EMT license within one year after probation and maintain it during duration of employment;
- \*must reside or work within GFD boundaries during employment;
- \*recruits are required to complete GFD fire academy and become certified as a NFPA Firefighter I. (time commitment: approx. six months, every Friday evening & Saturday);
- \*post high school education or equivalent combination of education and experience is preferred and will be considered.

#### Smoke Alarms

October 9-15, 2016 is Fire Prevention Week. The official theme for this year is "Don't Wait: Check the Date! Replace Smoke Alarms Every 10 Years". Fire officials have spent years teaching us "smoke detectors save lives" and "change your alarm batteries when the time changes" every 6 months in the Spring and again in the Fall. The message this year is intended to educate about life expectancy of smoke alarms. Smoke alarms do not last forever. While your alarm may still operate at 10 years old, it has become unreliable due to age. Please start systematic replacement of your alarms to insure they will continue to operate correctly. Check the manufacturer's date by removing it from the base and look for this date on the underside of the alarm.

#### Citizen Life Saving Award—Bryan Meyers



ADSTON

On the evening of July 20, 2016, Gladstone resident Steve Barton suffered a cardiac arrest. His wife called 9-1-1 and went to neighbor Bryan Meyers seeking assistance. Meyers immediately started bystander CPR. GFD EMT's & American Medical Response soon arrived and took over medical care. After many rounds of

CPR and advanced medical interventions, Mr. Barton was stabilized and transported to a local hospital for continued medical care. Two weeks later, Mr. Barton and his wife walked into the Gladstone fire station to express their thanks. At the September 13<sup>th</sup> City Council meeting GFD presented Bryan Meyers with the Citizen Life Saving Award. Without the early bystander CPR done by Mr. Meyers, the chances of Mr. Barton surviving would've been greatly reduced.

#### Street Parking Regulations

We are approaching the time of year when owners of boats, trailers, and RVs are preparing them for winter storage. Gladstone Code Enforcement would like to remind its citizens that there are city ordinances regulating on-street parking, and these ordinances are very specific as to the type of vehicles that can be parked on city streets. Chapter 10.04.230 of the Gladstone Municipal Code (available online on the city's website, www.ci.gladstone.or.us) describes parking issues. Please be mindful of neighbors and use alternative parking, such as RV pads or local RV storage facilities, etc. By following these guidelines we can all enhance city services, improve public safety and help make our neighborhoods more "neighbor friendly" for Gladstone residents.

#### Sidewalks and Clear Vision

A couple of residents recently expressed concern about sidewalks and clear vision. The Gladstone Municipal Code states that property owners are responsible for maintaining sidewalks abutting their property and are liable to any person suffering injury due to a defective sidewalk. The City's general standard for sidewalk maintenance states "not to exceed 1/2" vertical lift." This is similar to property owners being responsible for maintaining landscaping for clear vision of motorists at street intersections. Both the property owner and the City can be held liable for accidents when they are notified but fail to remove clear vision obstructions. Please check the condition of sidewalks along your property and check for adequate clear vision if your property is located at a street intersection.

#### What to Recycle at Home & Work

YES, Please: Mixed Paper, Cardboard & Cartons: junk mail, office paper, newspapers, magazines, phone books, cereal and cracker style boxes, milk, juice and soup cartons (rinse & drain). Plastic Bottles, Tubs & Buckets: clean bottles and tubs, 6 oz. and larger, plastic buckets 5 gallons or smaller, rigid nursery pots 4" across & larger. Metal Cans, Foil & Scrap Metal: clean cans, foil, pie plates & trays; empty spray cans, scrap metal up to 30 lbs and no longer than 30". NO, thank you: Frozen food boxes, coffee cups, pizza boxes, pet food bags, paper towels, paper plates, napkins & tissue: these contain wet strength, an additive, which means these items won't break down in the paper making process. Plastic Bags & Film: these items jam the machinery during the recycling sorting process, causing worker injury and additional labor costs. To-Go Boxes, Cups, Plates, Clamshells & Styrofoam: these plastics have limited or no demand by manufacturers. On the Side: Glass Bottles & Jars: clean glass bottles and jars go in SEPARATE recycling container. Motor Oil: recycle motor oil in marked, unbreakable container, not larger than two gallons, with a screw-top lid.

#### Hanging Tree Branches

Public Works is asking residents to trim low hanging tree branches that may damage vehicles or injure pedestrians by cutting branches seven feet (7') above sidewalks and fourteen feet (14') above streets. Please cut up your branches and place them in your yard debris cart. If Public Works determines there is a risk of damage or injury, they may cut your tree branches without notice. During winter months, please remove portable basketball hoops from city streets to reduce interference with street sweeping.

#### Wipes in Sewer System

Wipes can 'wipe out' costly sewer systems - Wet wipes, baby wipes, cleansing wipes, disinfecting wipes, surface wipes, hand wipes, antibacterial wipes, bathroom wipes or disposable moist towelettes. Whatever you call them, no matter what the packaging says, DO NOT FLUSH! The packaging might say they're flushable, but wipes, no matter the cleaning purpose, are causing expensive problems for sewer operators all over the world and should be disposed of in a waste receptacle and sent to a landfill to decompose. Residents are reminded that Chapter 13.12.070(3) of the Gladstone Municipal Code states: "The customer shall be responsible for the maintenance of the private sewer line from the public sewer connection to the premises served. The City shall not be liable for any damage accruing from the failure of a private sewer or of fixture of appurtenances attached thereto."

Fall is the time to start thinking about winterizing your irrigation system to protect your valuable investment before the first frost. Extended periods of freezing temperatures can cause considerable damage to underground irrigation systems. Expansion of frozen water will crack water lines and damage internal gearing in the sprinkler head. Initiating an annual winterization program is a positive step toward preventative maintenance care and will save you from problems next spring. You may hire a local landscape/irrigation specialist to perform the winterization procedure. This is also a good time to have your backflow device tested if not already done as required.
